Pursuant to the Migration Policy for Government Medical and Dental Colleges in Punjab, duly notified on **15th December**, **2023**, the University of Health Sciences (UHS), Lahore, hereby invites online applications, in accordance with the prescribed procedure, for the migration of students currently enrolled in the MBBS/BDS programmes of Government Medical and Dental Colleges, against available vacant seats. The details of the vacant seats are as follows:

ELIGIBILITY CRITERIA

- GIBILITY CRITERIA

 The applicant must be enrolled in a duly recognized Government Medical/Dental College in Punjab.

 For migration to the Third, Fourth or Final Year MBBS, the student must have passed the MBBS Second Professional, Third Professional or Fourth Professional University examination respectively.

 For migration to the Second, third or Final Year BDS, the student must have passed the BDS First Professional, Second Professional or Third Professional University examination respectively.

 A student studying in a foreign college/institute may apply for transfer to a medical/dental institute in Punjab subject to having completed at-least two years of studies and passed the corresponding final examinations for the period of of study completed in the foreign college / institute and having qualified the National Equivalence Board (NEB) Exam conducted by the Pakistan Medical & Dental Council (PM&DC).

For Foreign Students:

Aggregate percentage score of student at intermediate level (12 years of schooling) irrespective of the study group. In case the student has qualified intermediate level for a non-Pakistani scheme of education, he/she shall submit the scores on the basis of equivalence determined by IBCC irrespective of group of study.	80%
Aggregate percentage score of NEB exam.	20%

ADMISSION PROCEDURE

- Eligible candidates can apply through the online portal (http://migration.uhs.edu.pk). No manual applications shall be entertained. Fill in your particulars in the Application Form carefully.

 Select the college from the dropdown list where you want to transfer/migrate.

 Generate online Bank Challan of Migration Processing Fee (Non-refundable) of Rs.4,000/-. After depositing the fee in any branch of Bank of Punjab (through branch banking or online banking), enter the date of deposit and challan number on your application form and also upload the picture of paid challan receipt.

 Upload the following mandatory documents on the portal as listed on the Application Form. The documents shall be in picture/JPG format with a maximum file size of 2MB per document:
- format with a maximum file size of 2MB per document:

 a) CNIC/Passport Copy.

 b) Recent Passport-size Photograph.

 c) Attested Photocopies of SSC or equivalent, HSSC or equivalent, MDCAT/NEB, and detailed marks certificates of all professional examinations duly verified by the relevant university in case of Inter-University migrations.

 d) Proof of enrolment in parent institution clearly specifying the merit percentage at the time of admission.

 e) Receipt of deposit fee.

 f) No dues certificate from the parent institution.

 g) NOC from Parent Institute (for foreign students only).

 Go through the application form and its attachments before final submission. The form is editable till the final date of submission. Once submitted, no editing in the application shall be allowed.

IMPORTANT

- No migration is permissible from Public sector to Private sector and vice versa. Similarly, no transfer is allowed from BDS to MBBS and vice versa.

 Migration shall only be allowed on the basis of merit in the colleges with vacant seats.

- Migration shall only be allowed on the basis of ment in the colleges with vacant seats.

 No mutual migration of students shall be allowed.

 Applications must be submitted exclusively through the online portal. Any applications that are incomplete or are submitted in violation of the prescribed procedure shall be rejected. Failure to pay the migration fee by the specified date shall also result in application rejection. The Migration of MBBS/BDS students shall be allowed only once during the entire course subject to rules/regulations of PM&DC and affiliating Universities.

 Students who fail to avail this chance of migration shall be debarred for migration through remaining duration of MBBS/BDS course.

 Migrations shall be approved by a Centralized Committee of the Government of Punjah under the chairmanship of the Chief Migrations shall be approved by a Centralized Committee of the Government of Punjab under the chairmanship of the Chief Secretary, Punjab, and the final orders of migrations shall be issued by Specialized Healthcare and Medical Education Department.
