Bid Evaluation Report

A). Technical Comments from IT:

Tender for the procurement of Branded Desktop Computers, Laptop, Multimedia projectors, UPS, Printer & Scanner for UHS Lahore was published at University and PPRA Punjab websites on 09-01-2017 which was opened by the tender opening committee on 31st January 2017. Five companies M/S ABM Data System, M/S Compsi, M/S Nedo Corporation, M/S Siddiqui Engineering & M/S Nasco Traders were the participants.

The bids were technically evaluated against the tender documents; accompanied specifications were found to comply with the B.O.Q specification requirements. It is suggested that the 1st lowest bids from M/S Compsi (Rs.=113,000/- for branded desktop computers), M/S Compsi (Rs.=20,358/- for 600/650 VA UPS), M/S Nasco Traders (Rs.=12,000/- for multimedia projector screen), M/S Compsi (Rs=60,900/- for Laptop) M/S Compsi (Rs.=53,235/- for light duty A4 scanner) respectively, may be accepted by the technical & inspection committee.


For multimedia projector with installation, the bids submitted by the first lowest bidder (M/S Nasco Traders Rs.=125,000/-) and second lowest bidder (M/S ABM Data system Rs.=156,000/-); similarly for multimedia projector without installation, the bids submitted by the first lowest bidder (M/S Nasco Traders Rs.=111,000/-) and second lowest bidder (M/S ABM Data system Rs.=134,000/-) do not meet the tender requirements; whereas the bids quoted by the third, fourth & fifth lowest bidders appear to be on higher side; therefore the case is being submitted to technical & inspection committee for re-tendering.

For laser printer, the bids submitted by M/S Siddiqui Engineering (Rs.=117,000) and M/S Compsi (Rs.=136,539) are on higher side, therefore the case is being submitted to technical & inspection committee for re-tendering.
