## Bid Evaluation Report

### A). Technical Comments from IT:

Tender for the purchase of IT Equipment (Single Stage Two Envelope) for University of Health Sciences Lahore new campus at Kala Shah Kaku (KSK) under HEC funded project "Strengthening of Academic & Research Facilities University of Health Sciences" was published in Daily Newspaper, University and PPRA websites on 18-04-2017 & 23-04-2017 respectively.

In first stage, technical evaluation has been completed and following firms have been qualified or disqualified (lot wise) according to rule 16 of PPRA.

#### Technically Qualified Firms:

- 1) M/s: Generation systems ( LOT A & LOT B)
- 2) M/s: Pioneer Systems ( LOT B)
- 3) M/s: O & A Machine ( LOT D)
- 4) M/s: Office Automation Group ( LOT D)
- 5) M/s: Canotech ( LOT D)
- 6) M/s: Orange Technologies ( LOT E)

#### Technically Dis-Qualified Firms:

- 1) M/s: Orange Technologies ( LOT B)
- 2) M/s: Nedo Corporation ( LOT E)
- 3) M/s: Silicon Technologies ( LOT B)

In second stage, financial bids were opened by the tender committee in front of the representative of qualified firms dated 17-07-2017.

The bids were technically evaluated against the tender documents; accompanied specifications were found to comply with the B.O.Q specification requirements. It is suggested that the bids from M/S: Generations Systems (Rs. =9,352,186/- for LOT A), M/S: Generations Systems (Rs. =892,778/- for LOT B), M/S Canotech (Rs. =1,374,000/- for LOT D) and M/S Orange Technologies (Rs. =5,260,622/- for LOT E) may be accepted by the technical & inspection committee.

For LOT C (printers) & LOT F (public address systems) no bids were received; therefore the case is being submitted to technical & inspection committee for re-tendering of LOT C and LOT F.

## **B). Technical & Inspection Committee:**
